#### **NOTES FROM NOVEMBER LUNCH MEETING** WHAT'S AVAILABLE FOR CARE OF VETERANS

**Rosemary Na'a**, Medical Foster Home Coordinator: MFH is a partnership between adult foster home and a VA interdisciplinary home care team, granted initiative funds by Congress for Honolulu in 2008. The goal is to avoid institutional care. To become a MFH, the VA requires that the home be owned or rented by the caregiver and that the caregiver lives in the home, has 3 or fewer residents receiving care and veteran residents receive care from Home Based Primary Care. The veteran pays using pensions funds and Social Security. However, the VA provides case management and pays for medical care. In addition the care team includes a psychiatrist and pharmacist. Cost is about \$3500 to \$4000/mo compared to\$8000/mo in nursing homes. To start, only veterans of the wars in Iraq and Afghanistan are considered.

**Sara Tompkison**, Caregiver Assistance Pilot Program: Caregivers must be at least 21 years of age, have formal or informal experience in patient care, must be physically able to provide the needed care and have a written backup plan if they become incapacitated, including the identification of relief persons. Must be able to communicate any significant changes in normal appearance, behavior, or state of health and follow treatment plan.

**Mike Kitamura**, Sen. Daniel Akaka's State Director: An Akaka bill that gave10 million dollars country –wide to provide caregivers 30 days respite ended September 30. Sen. Akaka has introduced an Omnibus bill, Caregiver and Veteran Services Act, S1963. His motivation was that the welfare of vets is a cost of war, that families are also the victims, that there should be a choice to institutional care and that community and home care is less costly and probably better than institutional care. His bill furnishes medical benefits and monthly stipends to family members who stay home to care for seriously wounded in Afghanistan or Iraq. The bill passed the Senate 98-0 and is now going to House to negotiate the differences. It will take effect 27 days after enactment which may take 9 months.

#### SOCIAL, ECONOMIC AND ATITUDINAL FACTORS PREVENT PEOPLE WITH DISABILITIES FROM FULLY PARTICIPATING IN OUR SOCIETY

- Twenty percent of people with disabilities over 18 do not finish high school.
- Thirty-three percent eat out in restaurants at least once a week.
- 71% aged 18-64 do not have jobs.
- They are almost twice as likely as non-disabled people to say that inadequate transportation is a problem.
- Lack of access to public buildings and bathrooms is the reason why 4 out of 10 do not participate in community activities such as going to church or voting.
- 21% report that, on one or more occasions, they did not get the medical services they needed in the last 12 months.

# Changes in Application Procedure Effect Access to Handi-Van.

As of October 14, applicants are being required to **appear in person** and be assessed to determine their eligibility for renewal or for initial Handi-Van card. The Honolulu County Commission on the Status of Women has asked for clarification on issues that can place additional hardship on elderly and disabled.

- ✤ What was the reason for the change?
- Since the Handi-Van will be unavailable until approval, what plans have been made to help people get to their in-person assessment?
- What are the qualifications of those doing the assessment?
- ✤ What is the wait time for an appointment?
