VOTER OWNED ELECTIONS - Kory Payne, Field Director,

For far too long have mainland and local developers, tobacco, drug, and oil companies influenced our local government with their campaign donations. For far too long have our elected officials been forced to spend much of their limited time collecting large amounts of corporate money in order to fund their election campaigns - time which might have been better spent studying the vital issues confronting Hawai`i.

NOTES FROM JANUARY MEETING- ALICIA MULUAFITI

How Do Voter Owned Elections Work?

- The program is voluntary. Candidates decide whether to run on public money.
- No private money could be raised or used if running as a VOE candidate.
- Spending by candidates would be limited to the amount they receive from a fund by qualifying by raising a minimum number of signatures and \$5 from registered voters in their district.
- Enough public money would be provided to run and win a competitive race.
- VOE candidates agree not to seek or use private money while in office.

Why us it good for candidates?

- They will be free to run on the strength of their ideas not their wallets.
- They will avoid any perception of obligation towards campaign contributors.
- Free candidates from fundraising, allowing them more time to serve the public interest.
- Allow people from many different backgrounds to have a fair chance at running for office.

Will it work?

- In Arizona, in 1998 79% of all races were won by the candidate with the most money. In 2002 the percentage dropped to 2%.
- Both parties benefited. 22 Republicans and 17 Democrats won using public funding.
- In Maine, 79% of all Maine legislators won using public funding in 2004.

Is Public Funding good for Labor?

- Labor is vastly outspent. Big business gave \$2.2 billion, labor unions only \$187 million.
- •In Hawaii, unions contributed only 1/5th of the total funds given to candidates in 2004.

Re: SB 2343--Criminal History Record Checks heard on Fri., 2/3. **Passed** Health and Human Services with technical amendments. I spoke to Sen. Chun-Oakland after the session and she said that they feel a bit more confident of passage as they tried to address many of Sen. Hanabusa's objections of last year. Sen. HB 2670 Creates Authority for Universal Health (Silver Legislature Bill) **Passed** Health Committee. HB2107 Caregiver Grant passed Health committee.

Hi---and HOORAY!! HB3128, our single-payer universal health care bill, passed out of committee today, against all odds!! An initial double referral to two committees is considered the "kiss of death" usually, so we're jumping up and down for joy!

It was touch and go, and the first attempt to get a quorum to vote on HB3128 failed. The second attempt the next day, would have been the <u>last</u> try, and they were one short of a quorum again---and Jim was running around catching legislators!

But as soon as the number for a quorum was reached, they voted, and the bill passed in minutes! Thanks to everyone for your testimonies at the Feb. 3rd hearing. There were as many of "Us" as there were of the vested interests testifying on the bill, and we held our own! Jim Brewer, Renee Ing
