MEDICARE CAUTIONS ABOUT FRAUDULENT PHONE CALLS

A caller says he needs to know the name and address of the Medicare member in order to mail a new card. Another caller tells the Medicare member to make a one-time lump-sum payment and premium deductions from the member's Social Security benefits check will cease forever so please provide a bank account number. Medicare does not sell products or services nor is issuing a new card.

Do not volunteer personal information to anyone claiming to call from Medicare. If this happens, report the call to SMP Hawaii, a fraud prevention program at Executive Office on Aging at 586-7281. If you think you have given your bank account number to a scam artist call your bank immediately.

HOW TO FIND, TRACK AND SEND TESTIMONY FOR 2009 LEGISLATIVE SESSION

Go to the legislature's website at www.capitol.hawaii.gov and click on the link to "Bill Status and Documents." The first box on that page will give you a resource for doing text searches to find bill numbers, if you don't already know them. Once you have bill numbers, you can put them into the blank space there in the first box and then choose what you want to see – 'status' (which is to say, the measure history), 'text' (which will give you all versions of the bill/s you've chosen), and 'committee reports' (which are the reports generated when a measure moves from one committee to the next).

To send in electronic testimony, follow the instructions on the bottom portion of the hearing notice. There on the "Bill Status and Docs" page, go down to the second box ("2007 interim/2008 regular session hearing notices") and choose the hearing notice you want. Instructions on providing testimony in various ways will be found in the section below the list of actual measures, beneath the line that says either "Decision Making to Follow" or "Decision Making to Follow if Time Allows." *Public Access Room*

JOIN THE FUN

In a 7-day time span that started January 21, three to four thousand bills were introduced, all of them envisioned by someone as a way to improve life in Hawaii Nei in some way. The entire rest of the session, until early May, will be devoted to winnowing those bills down to a few hundred laws. In the process, people will disagree, sometimes strongly, on which of them will truly help the most, and how.

Bills and resolutions will bump along from hearing to hearing, some changing, some staying the same, some dying. An amazing array of folks will sit in the hearing rooms, waiting their turns to be heard. They'll be elderly and young, homeless and wealthy, professional, amateur, clueless, profound, and everything in between. It's an exasperating, exhausting, empowering thing to see and be part of – it's democracy in action.

Come down to the Capitol and see for yourself. Hear the array of viewpoints being presented, debated, and (for some of them) turned into law. Bring your own opinions, your testimony on the bills that matter to you, and bring your laptops too if you'd like – almost the entire Capitol is WIFI-enabled now. (And if you can't come down, you can still write. You can be an active part of the legislature without leaving home these days, and it's pretty easy to learn how. NOTES FROM JANUARY LUNCHEON- Coral Andrews, Vice President Healthcare Association of Hawaii. "Waitlisted Patient Issues, A Symptom of our Broken Health care System."

"The Health Care System is constipated", declared Andrews. Hawaii's healthcare system is broken. Symptoms of this broken system are waitlisted patients. These are patients deemed medically ready for discharge and no longer in need of acute care services but who cannot be discharged (due to various barriers) and therefore must remain in the higher cost hospital setting.

A Waitlist Task Force, working under the direction of the Healthcare Association of Hawaii's (HAH) Board of Directors, studied the waitlist issue and identified four barrier categories that contribute to the waitlisted problem. They are: reimbursement, capacity, regulatory/government and workforce. With waiting lists for any vacancy, nursing homes will select those whose reimbursement is assured, who present no behavior problems, and who require no special treatment for special needs. Especially out of luck because staff has no behavior management training or homes have not the special equipment for the care, are geriatric patients and younger, usually male long-term care patients. Recommendations aimed at addressing these barrier categories are summarized in the 2008 and 2009 Reports to the Legislature. QUEST EXPANDED ACCESS APPROVED DESPITE QUESTIONS

The state will proceed with the start of a new managed healthcare program for Medicaid recipients on Feb. 1, though some doctors and medical service providers say they aren't going to participate. Quest Expanded Access or QeXA — includes coordinators who will be tasked with lowering costs by improving care and decreasing hospital and nursing-home admissions for Aged, blind and disabled on Medicaid. Dr. Kenneth Fink, state Med-Quest Division Administrator said he would look into reports of health plan agreements being offered to physicians, pharmacies and others with reimbursement rates that are lower than are provided currently by the state.

"I've heard that," Fink said. "I've made a request that people send the contracts to me." The Small Business Regulatory Review Board requested that Fink report back to it on the program in the spring and said it passed a motion for review of QeXA rules relating to reimbursement.

- · Nursing Home Help \$87 billion in help for state Medicaid programs. Medicaid funds are the single largest source for nursing home care.
- \cdot COBRA Help A 65% percent subsidy for 9 months for workers who have lost their jobs from September 1, 2008 through December 31, 2009 so they can keep their health
