### CLARIFICATION ON KUPUNA CARE FUNDING.

The funds recently released for Kupuna care is in addition to funds already in the State's base budget. Additional funds are needed to help shorten the long waiting lists for services because of our aging population. Kokua Council advocates for these funds be added to the base budget, to alleviate the necessity of going to the legislature each session.

### NOTES FROM JANUARY LUNCHEON: Joy Yadao, St. Francis Palliative Care

Palliative care at St. Francis differs from Hospice Care and is not just pain relief any more. It is for anyone with a serious illness who wants to make sure that whatever future the rest of their lives may hold, someone will be there to help them be comfortable and be at peace. Care can be provided at any stage of an illness and at the same time as curative treatment. A team consisting of a doctor, social worker, nurse and minister after referral from your family physician will consult with the patient and family wherever the patient is, including all health care settings.

The goals are to enhance the quality of life for the patient and family and help them understand and discuss life decisions. At present, there is no waiting list and St. Francis Healthcare System absorbs the cost. Call 547-8068 for more information.

# President's State of the Union Address Avoids Call to Cut Social Security

**President Obama** said, "To put us on solid ground, we should also find a bipartisan solution to strengthen Social Security for future generations. And we must do it without putting at risk current retirees, the most vulnerable, or people with disabilities; without slashing benefits for future generations; and without subjecting Americans' guaranteed retirement income to the whims of the stock market."

On Meet The Press recently, President of the Senate, Senator Harry Reid was asked if America should "fundamentally change" Social Security to deal with the national debt. Many other Democrats have flubbed this question, but Reid hit it out of the ballpark. He said: "One of the things that always troubles me is when we start talking about the debt, the first thing people do is run to Social Security. Social Security is a program that works...Stop picking on Social Security."

## Message from Public Access Room (PAR)

- The Legislature's website (<a href="www.capitol.hawaii.gov">www.capitol.hawaii.gov</a>) has enhanced its committee pages for any particular committee, you can now view not only its members, but also the measures currently in its hands, the hearings it has scheduled and news and information related to its proceedings. Just go to the "House" or "Senate" page, select "Committees" and go from there.
- Do you receive email alerts when a hearing is scheduled? Now that all the legislative committees have been formed, don't forget to update your alert list. And remember, you can also request to be advised when particular bills or resolutions are scheduled. Go to the "subscribe to hearing notices by e-mail" link on the Legislature's "Bill Status and Documents" page. We've attached helpful instructions here for those new to the alert procedures.
- Want to see all the bills introduced? Don't forget the 'list of lists' down near the bottom of the "Bill Status and Documents" page (the list is actually entitled, "2011 Regular Session Bills Introduced, Passed, and Vetoed"). This is where you'll find lists of all Senate Bills and House Bills, in a format that's easy to browse and export.
- Interested in seeing documents published on a particular day? This is also where you will find the links to the "Daily Documents" reports.

**LETTER FROM SEN. DAN INOUYE:** "Last month, we lost out on the opportunity to pass an omnibus federal budget. The failed omnibus included 141 earmarks, totaling about \$321 million for Hawaii. These monies would have funded:

- Road construction and public transit buses for all the counties;
- Renewable energy initiatives in wind, solar, biomass and bioalgae, ocean thermal energy conversion (OTEC) and electric vehicles;
- Support for farmers and ranchers in the diversification of our agricultural base, and our need for food security;
- Greater access to quality health care, educational and job training opportunities for those most in need:
- Cutting-edge innovation in science and technology, supporting many of Hawaii's most promising high tech small businesses.

### REAPPORTIONMENT PLANNING TO START.

This is will effect the development of policy and distribution of resources. In Hawaii, The President of the Senate, Speaker of the House, and the minority leaders from each house each select 2 redistricting commissioners and 4 advisory committee members. The commissioners then select a ninth member to become chair. This results with both Republicans and Democrats equally represented on the commission. The appointments must be made and the first meeting held by May1. Their report is due 180 days later after holding at least I hearing on each island and is final unless challenged in court. This seems like a good system and politicians are not directly involved, Commissioners owe their positions to politicians and seem to be chosen to protect the interests of those who selected them.
