## OBAMA PROMISES BID TO OVERHAUL SPENDING ON RETIREE PROGRAMS

Recently, President-elect Barack Obama said that overhauling spending on retiree programs would be "a central part" of his administration's efforts to contain the federal budget. "The Alliance for Retired Americans will reiterate our policy positions and stress the need for the quality of life of seniors not to suffer," said George J. Kourpias, President of the Alliance. "We appreciate that President-elect Obama has consistently opposed privatizing Social Security and is for raising the caps on income subject to the Social Security tax, which will help the finances of Social Security. He also wants to reduce Medicare waste and fraud and introduce more efficiencies, and plans not to tax the first \$50,000 of seniors' income. We are confident that he will continue to stand up for retirees."

#### APPOINTMENT OF OLD FRIEND

Jeanette Takamura, Ph.D., former director of the Hawaii Executive Office on Aging, is overseeing the Obama-Biden transition for the Administration on Aging, the Assistant Secretaryship she held during the Clinton Administration. During her position here, she initiated Project Hope, the first attempt at a long term care financing program in 1993. She has also been the first woman dean of the School of Social Work at Columbia University.

# JLCAIP/KUPUNA CAUCUS TOP VOTES FOR 2009 LEGISLATIVE SESSION

Members present at the December 5th meeting of the Joint Legislative Committee on Aging in Place and the Kupuna Caucus cast votes for their legislative priorities for the 2009 session. The top 4 are:

- Maintain Kupuna Care Program base funding
- Restoration of Senior Center funding if DOH cuts funding
- Posting of annual inspections of care homes foster homes on-line.
- Cash & Counseling Project

# LCAO Makes Recommendations on Obama Executive Order for Seniors

The Leadership Council of Aging Organizations is a consortium of prominent national aging advocacy organizations that represents millions of older Americans. Among LCAO's recommendations is that the Obama Administration create a White House Office on Older Adults (or the position of Domestic Policy Council Advisor on Older Adults) to develop, lead and coordinate the Administration's policy agenda on crosscutting issues that assist and empower older Americans. LCAO also recommends giving the Secretary of Health and Human Services the authority to use Medicare's bulk purchasing power to negotiate prescription drug prices, and halting the so-called "premium support" demonstration project in 2010 that would require traditional fee-for-service Medicare to compete, based on cost, with heavily subsidized private plans in certain areas. The coalition also wishes to allow early retirees to buy into Medicare, along with several other steps.

## 5-STAR RATING SYSTEM FOR NURSING HOMES

The Centers for Medicare and Medicaid Services (CMS) created the Five-Star Quality Rating System to help consumers, their families, and caregivers compare nursing homes more easily and to help identify areas about which you may want to ask questions. The purpose of the Joint Legislative Committee on Aging in Place is to develop a comprehensive public policy program to support family caregivers who provide unpaid, informal assistance to persons sixty and older with physical or cognitive disabilities. The Committee will consider providing support in categories including but not limited to: coordinated services and policies, training and education, respite services, financial incentives and balancing work and caregiving. It usually meets jointly with Kupuna Caucus, the first Friday of each month, 2 p.m. in room 229, State Capitol. Co-Chairs are Senator Les Ihara, Jr. and Representative Marilyn Lee. Come and show by your presence your support for their issues.

#### MEDICARE CAUTIONS ABOUT FRAUDULENT PHONE CALLS

A caller says he needs to know the name and address of the Medicare member in order to mail a new card. Another caller tells the Medicare member to make a one-time lump-sum payment and premium deductions from the member's Social Security benefits check will cease forever so please provide a bank account number. Medicare does not sell products or services nor is issuing a new card.

Do not volunteer personal information to anyone claiming to call from Medicare. If this happens, report the call to SMP Hawaii, a fraud prevention program at Executive Office on Aging at 586-7281. If you think

you have given your bank account number to a scam artist call your bank immediately.
