Notes from June Luncheon: What Does HAH Do for Seniors?

Coral Andrews, RN, MBA, Vice President, replaced scheduled speaker George Greene C.E.O. who was traveling out of state. The Healthcare Association of Hawaii (HAH) is a non-profit organization representing Hawaii healthcare providers.

The Healthcare Association of Hawaii worked with a range of stakeholders from the private and public sector to pass legislation requiring home care agencies to be licensed. Home care agencies provide services to consumers in their homes or home-like settings such as bathing, feeding, grocery shopping, etc. The services are consumer directed as opposed to home health services, which are physician directed and include services such as skilled nursing, physical therapy, etc.

Prior to the law being passed, a general excise license was all that was required for a home care agency to operate and have access to elderly and disabled in their homes. Nationwide, there is a trend toward requiring licensure with the goal of providing minimum protections in some of the following key areas: a criminal background check, a communicable disease check, and minimum competency training so that aides can assist consumers in the areas described above without causing jeopardy to the consumer.

A group of stakeholders is in the process of writing the Administrative Rules and all are hopeful that the appropriation to the support the regulatory staff in the Department of Health will be secured during the 2011 Legislative Session. *"We urge your continued support on this important measure so that consumers can be assisted in making appropriate choices when determining who should provide home care services to themselves and their loved ones"*.

Troubling Reports on Discharge Planning Leave Hospitals with Some Explaining to Do

With the health reform implementation process under way, some hospitals around the country have come under scrutiny for their cost containment measures and their high infection rates. For years now, hospitals have been discharging patients after shorter stays in order to save money, but a new study of Medicare heart failure patients seems to suggest that the shorter stays are not even cost-effective.

The study, conducted by a cardiologist at Yale University and set to be published in the Journal of the American Medical Association, concluded that patients who were discharged from the hospital after a short stay were more likely to return to the hospital for additional care within a month of their initial treatment, making the entire process very expensive. The data from the study found that while the length of hospital stays for heart failure patients declined by 26 percent, the readmission rate increased from 17.3 percent to 20.1 percent. Early discharges are not the only problem hospitals face, as high infection rates have left many fearful of going to the hospital. A Consumer Reports study of intensive care units at 926 hospitals across the country found that some hospitals have strikingly high infection rates.

2010 LEGISLATIVE SESSION ROUNDUP

Like the rest of the nation, the Hawaiian legislature made needed reforms in order to balance the state's \$1.2 billion budget deficit. The Democrat-led legislature used innovative ways to deal with the crisis - such as raising the taxes on petroleum products, a measure that lessens Hawaii's dependence on foreign oil and reinvests in renewable energy sources, and voting to reroute sitting monies from the Hurricane Relief Fund terminate teacher furloughs and ensure that students remain more days in the classrooms. Notably, the legislature had to override 11 out of 14 vetoes by their Governor.

PROGRESS: Not vetoed:

Our top priority, Senate Bill 2469, which includes an appropriation from the Emergency and Budget Reserve Fund (the Rainy Day Fund) for Kupuna Care services **has not been vetoed but still needs to have funds released by the Governor.**

HB1902 Extends sunset date for the Long Term Care Commission to 2012. HCR 13 Extends deadline for Home for Life taskforce.

VETOED:

HB1212 Disallows the Department of Commerce and Consumer Affairs from disclosing pending complaints against a business or professional to the detriment of consumers who need the information for informed decision-making. **Hurray! We supported this veto**.

SB2472 Allows grand children of elderly housing project residents to temporarily reside with residents in certain family crisis situations.

SAFEGUARD #5: Another Health Care Myth Debunked: Taxing Health Benefits

With so much misinformation going around about health care, it is important to continue addressing the false rumors about reform as they arise. There is an internet scam regarding W-2 tax forms that has been in circulation since the passage of health care reform. In the health care reform law, there is a provision that W-2s will now have a box where the employer puts the cost of a worker or retiree's health care. Nothing is added to income. It is simply a for-your-information box and does nothing to change a person's income or taxes owed.
