#### **Rebate Checks Begin in May**

The President signed a multibillion-dollar economic package that means \$300 to \$1,200 rebates for many American households. Rebates are set to go out beginning in May, and will include seniors living on Social Security. Most taxpayers will receive a check of up to \$600 for individuals and \$1,200 for couples. Seniors earning at least \$3,000 and who owe little or no taxes would get \$300 for singles, \$600 for couples. Those making more than \$75,000 and couples with income over \$150,000 will get smaller

checks. Rebates to seniors and disabled vets were scaled down from \$500 under the original Senate package after the president personally lobbied against including them. Seniors need to file a 2007 federal tax return, either the IRS Form 1040 or the 1040A-short-form, to receive their stimulus checks. This is true even if their income had been low enough that they were not required to file in previous years

#### NOTES FROM FEBRUARY LUNCH MEETING

Marilyn Seely; The Leahi master plan envisions a long-term care system that would allow Leahi to expand into the community and become a center of excellence for long-term care (LTC). Leahi hospital on 6.7 acres and adjacent to 10 acres of state property, is ideally situated next to Kapiolani community college with its family caregiving training program and to mental health facilities. The last structure at Leahi was built in 1950. The governor has just released funds for the repair of Leahi's physical plant.

There are 9 beds at Leahi still set aside for acute tuberculosis cases. Only 2 of those beds are currently occupied. Creative possibilities include the Eden Alternative, The Greenhouse Project and a think tank to meet the needs of the elderly.

SB 3237 is considered a creative holistic approach and could be a prototype for LTC services in Hawaii. If passed, an interim report would be due 12/209 and the master plan would be due in 12/2010.

**Leigh** –**Wai Doo** then reported that this might be "the most important project that Kokua Council might ever do." He said it could be a catalyst that will affect the next 3 generations of seniors. It is imperative that it be implemented as soon as possible.

However, the Leahi bill died for this session. We hope the Leahi group will pursue private foundation funding to pursue this worthwhile project .Ed.

Renee Ing distributed information about a cheaper, quieter alternative to the steel on steel rail system chosen by Honolulu officials. The Phileas magnet rail system runs on rubber tires. www.apts-phileas.com

## **UPDATE ON LEGISLATIVE PRIORITIES-2008**Bills alive and crossing over to other house

SB 2204 Removes cap on Corporate Contributions to campaigns. Oppose, See below HB2455

**SB** 3255 Establishes Long Term Care Commission to explore options for financing long term care.

**SB 2830, HB 2196** Omnibus bills for family caregiving. Increases funds to Kupuna Care to provide respite, tax credits for caregivers and home modification ,aging in place, develop cash & counseling model.

**SB2047** This home modification tax credit bill establishes an income tax credit for taxpayers who make modifications to their home to increase accessibility for individuals with disabilities or special needs.

SB 2150 Expands Adult Protective Services.

SB 2831 Appropriates funds for U.H. Center on Aging.

SB 2151 Provides neighbors islands with a LTC ombudsman.

**HB 7** I-Save Rx Prescription Drug permits Hawaii joining other states to negotiate lower prices.

**HB 2198** Establishes a task force to focus on needs of Grandparents raising grandchildren.

**HB1993** Universal Health Care appropriates funds to cover uninsured residents.

SCR 25 Convenes task force to study feasibility of establishing a Department of Aging.

SB 3237 The Leahi Project

**HB 2836** Changing appeal process for denial of benefit by Health Insurers. A success since we opposed this bill.

HB 2112, SB 2152 Establishing a Department of Aging but has become a Resolution SCR 25

HB 2455 Removes cap on Corporate contributions. But still alive in Senate. We oppose this.

## Prescription Drug Group Spends \$22 Million Lobbying Washington in 2007

The pharmaceutical industry's main trade group spent over \$22 million on Washington lobbyists in 2007, the Associated Press reported. This is a 25 percent increase over 2006. Also, the Wall Street Journal reported that prescription prices rose eight percent in 2007, twice the rate of inflation. Some industry analysts, the Journal noted, believe that the increases were aimed to drive drug prices higher before any possible Medicare reforms could be enacted by Congress.

#### LETTER TO EDITOR: WHAT EVER HAPPENED TO THE RX REBATES? Bruce McCullough

It has been over seven months since the Legislature passed Act 60 which required the Department of Human Services (DHS) to negotiate with pharmaceutical companies to lower the cost of prescription drugs for residents who have no drug insurance.

The language of the law is clear and unambiguous. It states: "... the administrator shall use the administrator's best efforts to obtain a rebate amount equal to or greater than the amount of any discount, rebate, or price reduction for prescription drugs provided to the federal government." In other words, DHS is required to seek rebates from drug companies so that the state can pass on those savings to residents.

Unfortunately, DHS Director Lillian Koller has done little to implement the law. Indeed, the Hawaii Rx Plus program has saved an average of a mere 9 cents a claim for secondary rebates, a far cry from the legislative intent.

Why are Director Koller and Governor Lingle failing to pursue rebates from the drug companies? More importantly, why do they continue to ignore the law?
