Notes from our April Meeting

Barbara Stanton, State Director AARP: AARP is undertaking a survey to cost out home improvements that will enable people to stay home longer. The information will be useful for the legislature as well as advocacy groups. AARP supported legislation to provide a refundable tax credit for caregivers and to extend income eligibility to 150% of poverty for the Hawaii Rx assistance program. Also important are aging in place and proper placement at the proper time.

Deborah Jackson, Director of Eldercare Hawaii. Her organization (www.eldercarehawaii.com) is a resource for eldercare information, resources, support, training and providers for family caregivers and seniors. The staff assists with planning, counseling, mediation, information and referrals.

Nanette Geller, a geriatric mental health consultant is concerned about how to make long term care institutions more home-like. It is possible to have a good quality of life in spite of impairments. Having loving care providers, whether unpaid or professional is most important.

While not a panelist, Kokua Council member **Florence Lau** shared her experience in organizing her condo to assist the growing number of aging tenants “age in place”. Her experience taught her to

1. Get support and approval from the board of directors and the building manager.
2. Start out with a socializing activity so tenants get to know each other.
3. Find out from them what their needs are.
4. Include all ages. For example, don't call it a senior group or caregivers' group; call it a singles' group or a better living group.
5. Her condo now has a buddy system on each floor.

NEW WATCH DOG ORGANIZATION FORMED

Below is a letter sent to Speaker of the House Calvin Say in April as the first action of CITIZEN VOICE.

“After the demise of Common Cause there was a lapse in citizen oversight of the legislature. This lack of oversight has led to blatant disregard for ethical behavior by the legislature, especially the House which is under your purview.

Now comes Citizen Voice, organized to step up and fill the gap left by Common Cause as the watchdog organization reporting on ethical lapses of the legislature. We do not intend to simply report, we fully intend to shout long and loud when your House ignores ethical standards and/or the law.

A case in point is Representative Herkes who according to the *Pacific Business News* article of April 14, 2006, allowed an industry representative to draft amendments to a bill regulating that industry's activities. **‘Kaiser Permanente Hawaii lobbyist Chris Pablo acknowledged that he drafted the amendments to the bill and circulated them among other health plans, like the Hawaii Medical Service Association, to enlist their support’**. The resulting amendment, which was no longer a simple bill to cancel the sunset

provision of the rate regulation law—was all new language highly favorable to the health insurers. One section in particular practically assures that any attempt at rate regulation would be tied up in litigation virtually forever.

Citizen Voice expects you, as speaker, to remove the healthcare insurance industry representatives from Chairman Herkes office and put Bill SB2917 back to its original wording and pass it in order to reinstate rate regulation of the healthcare insurance industry. Moreover, if you wanted to be seen as a true leader of an ethical organization you would remove Rep. Herkes of his Chairmanship of the CPC Committee as a warning to all Chairs that unethical conduct will not be tolerated. 2006 LEGISLATURE ENDS, HOW WE FARED

(*Silver Legislature Bill **Kokua Council Top Priority issues)

PASSED, Going to Governor for Signature:

****CRIMINAL HISTORY CHECKS:** SB2343—Requires criminal history checks on persons providing care or having access to frail elderly, mentally retarded and rehab clients.*

****UNIVERSAL HEALTH CARE:** SB2133—Establishes a Hawaii Health Commission to continue the work of the Healthcare Task Force to study universal coverage). HB3116—Provides for a 3-year pilot program that provides health coverage for children ineligible for any state or federal health care coverage. A family earning up to \$60,000 for a family of four would qualify.

****LONG TERM CARE:** HB 1900—Appropriates \$206,000 to Kapiolani Community College to establish a Long-term Care Training Initiative.* SB 3252 —Appropriates \$500,000 to EOA for the Kupuna Care program* and \$80,000 for caregiver support services and policies. Kupuna Care provides services for those above poverty level paid for by client donations. SB 3253—Establishes a Joint Legislative Committee on Family Caregiving.

****AFFORDABLE HOUSING:** SB2958—Provides funds for repair and maintenance of public housing*, support services for homeless and rental income supplements; and bond issuance for construction of affordable housing. Also provides that minor children may reside in state housing for elders where a grandparent is the primary caregiver,* with a five per cent set-aside of units for that purpose.

PRESCRIPTION DRUGS: SB3003—State Pharmacy Assistance Program extends income eligibility requirement to 150% of federal poverty level; covers all ages, and will cover extra costs incurred for Medicaid aged, blind and disabled who were shifted to Medicare Part D.

DEAD:

VOTER OWNED ELECTIONS, REFUNDABLE TAX FOR CAREGIVERS, DEATH WITH DIGNITY/COMPASSION, and GAS CAPS (now requires more information about pricing formulas and can be reinstated by the Governor.)

OTHER ACTIONS TAKEN BY KOKUA COUNCIL

We helped defeat: Bill to remove cap on corporate donations for legislative campaigns (see letter below) and HB3128, tax credit for purchase of long term care insurance.

We supported Kukui Garden tenants in their efforts to stop the sale to profit-making private company.

LETTER to the EDITOR

Yesterday, there was in fact a push to pass SB 2992, but because the reaction from the grassroots community was so strong, the bill was defeated instead.

The significance of this shouldn't be underestimated. Can you imagine if the \$1,000 limit was done away with, and special interests could give as much money as they pleased to candidates and committees?

For all of you who wrote, called, emailed, hosted and attended house parties, sign-waved and

canvassed, you should really pat yourself on the back. We are so appreciative of your volunteer efforts. Mahalo. We are now more determined than ever before to pass "The reform that makes all reforms possible," Voter Owned Elections (Clean Elections). We will be launching an ambitious one-year plan to get our bill passed next year. We hope you'll join us in our massive public education effort, which will begin soon. Stay tuned for more.
