NOTES FROM APRIL MEETING – Bruce Bottoroff DIVIDED WE FAIL – A MOVEMENT FOR POSITIVE CHANGE

For most Americans, affordable health care and long-term financial security go hand in hand. Too many people struggle to pay for health care and worry whether they will have real retirement security. THE RIGHT OF WAY: PEDESTRIAN AND DRIVER SAFETY TIP

Drivers: Look out for pedestrians that may be hidden from view by other vehicles that have stopped. Watch for pedestrians in the crosswalk as well as oncoming traffic when making a right or left turn.

Pedestrians: Look left, right, then left again for vehicular traffic before steeping into the roadway. Continue to look for oncoming vehicles while crossing.

Keep to the right of the crosswalk, and be patient and alert when crossing the street.

BIPARTISAN ELDER JUSTICE ACT INTRODUCED IN CONGRESS

Sens. Orrin Hatch (R-UT) and Blanche Lincoln (D-AR), and Reps. Rahm Emanuel (D-IL) and Peter King (R-NY), introduced the Elder Justice Act on March 29th (<u>S. 1070</u> and <u>H.R. 1783</u>). NCOA is a Coordinating Committee member of the Elder Justice Coalition, a bipartisan, 525 member group which supports both bills. The bills would:

- Establish an Elder Justice Coordinating Council chaired by the Secretary of Health and Human Services and the U.S. Attorney General and would include the head of every federal agency that is involved with elder abuse, neglect and exploitation.
- Establish an Advisory Board to the Coordinating Council that would have 27 private citizen members who are experts and advocates on the issues surrounding elder abuse, neglect and exploitation.
- Award grants to establish and operate both stationary and mobile forensic centers and to develop forensic expertise pertaining to elder abuse, neglect and exploitation.
- Provide a federal funding source for Adult Protective Services (APS) programs. Up to this point, there has not been dedicated federal money to support APS programs.
- Require the Secretary of Health and Human Services to carry out activities that provide incentives for individuals to train for, seek and maintain employment in long-term care facilities and provides funding through 2011 to support these activities.
- Address LTC staffing problems by establishing incentive grants to attract qualified staff, retain staff, training staff and management.
- Require all adjudications of criminal violations by nursing facilities or employees to be reported, as well as consumer rights information, on the official Nursing Home Compare Website.
- Improve the training of surveyors with respect to investing allegations of abuse, neglect and misappropriation of property in programs and long-term care facilities that receive payments under Medicare and/or Medicaid.

The Institute for the Future of Aging Services also released a report entitled "<u>The Long-Term Care Workforce: Can the Crises be Fixed?</u>" The report examines: (1) the composition of the long-term care workforce, why it is perceived to be in crises and future trends; (2) explores the range of options to ensure an adequate supply of competent long-term care professionals; and (3) identifies high-priority information gaps that will strengthen the evidence base for future workforce improvement.

EDEN AT HOME

The Eden Alternative is a wonderfully innovative concept for changing the delivery and environment of long term care facilities. They have recently shared the results of a pilot program here in Hawaii re-thinking how we care for our elders and each other in the home. A key concept is that the elder is an active participant in their care plan. Thus there are no "caregivers" or "care receivers" but there are "Care Partners".

Paying attention to only the physical needs is not enough. The bulk of suffering among our elders is loneliness, helplessness and boredom. An antidote to loneliness is easy access to human and animal companionship. Having the homebound elder participate in decisions concerning their daily life and care, not making decisions for them, is the antidote to helplessness. Creating an environment in which unexpected and unpredictable interactions and happenings can take place is an antidote to boredom.

2007 LEGISLATURE ENDS; HOW WE FARED

PASSED, Going to Governor for Signature *Kokua Council Top Priority issues

*HB10 Mandates DHS to negotiate rebates with drug manufactures. But **Vetoed** by Governor.

*SB 1916 Support of family caregivers by appropriating funds for Kupuna Care and 1 Stop Centers, extending joint legislative Committee on family caregiving and includes grandparents raising grandchildren, requiring needs assessment of caregivers and families.

*SB12 Reinstalls oversight of Health Insurance by Insurance Commissioner, removes sunset date.

HB375 Increases penalties for drivers who fail to stop for pedestrians to\$150, to pedestrians who jaywalk to\$100. Pilot project to test crosswalk safety. Study adequate time to cross intersections.

*SB1184 Adult Protective Services changes dependent to vulnerable, allows department to investigate when adult has been abused OR is threatened with abuse.

SB1182 Increases Personal Needs Allowance from \$30 to \$50 for residents in LTC facilities.

Included in DHS budget: Provides comprehensive dental care for indigent adults (was HB325).

HB1337 Improves consumer protection in pre-paid funeral trusts.

AFFORDABLE HOUSING, Legislature allots 25 million to keep Kuhio Gardens affordable.

HB 807 Establishes Office of Long Term Care Ombudsman by statute.
