NOTES FROM SEPTEMBER LUNCHEON

ACLU-89 AND STILL DEFENDING CIVIL RIGHTS: ACTIVISIM AT ANY AGE. LAURIE TEMPLE, STAFF ATTORNEY The American Civil Liberties Union was founded in1920. Locally a staff of 5 and volunteers are working to defend the individual rights and liberties guaranteed by the Constitution and the bill of rights and to extend them to those that have traditionally been denied.

During the 2009 legislative session, besides monitoring hundreds of bills, ACLU testified in writing or in person on over 85 bills and resolutions. Four bills were enacted into law and 3 resolutions were adopted. The bills passed (SB777) requires any state-funded sex education program to provide medically accurate sexuality education, (SB539) ensures that the Dept. of Public Safety focuses on reentry and reintegration support and services. (SB1058) establishes a taskforce to examine current medical marijuana medical laws and make recommendations for improvement. (HB358) allows for the development of an alternative program to incarceration for persons with drug addictions.

Legislative priorities for 2010: Supporting Civil Unions, Eliminating Mandatory Minimum Sentences,

U.H. MANOA REVITALIZES CENTER ON AGING BEGINNING AUGUST 1, 2009

Interim Director, Dr. Colette Browne plans to provide the academic and administrative leadership to encourage research, policy and educational initiatives on issues of aging for the state, region and nation. Primary tasks will focus on:

- Developing the Center's long-range development goals and objectives,
- Initiating cross-disciplinary discussions of current projects and potential projects of research and collaboration among key faculty,
- Reviewing educational offerings and trainings in aging, and
- Developing the Center's program of research for the purpose of securing public and private funding opportunities.

NEW IMPROVED ELDER ABUSE LAW

A law passed last legislative session covering Elder Abuse and Neglect widens the coverage of those abused adults now protected by the rules. *Kokua Council lobbied for this change*.

Instead of "Dependent adult" the law is now entitled "Vulnerable" Adult Abuse and Neglect and is available to any person 18 years of age or older who because of mental, developmental or physical impairment is considered vulnerable to abuse.

What does vulnerable mean?

- Any of the above persons who are unable to communicate or make responsible decisions to manage their own care or resources: or
- Carry out or arrange for essential activities of daily living; or
- Protect oneself from abuse.

A vulnerable adult is one who has suffered abuse or is in danger of abuse if immediate action is not taken. Report adult abuse and neglect anonymously by calling 832-5115 Monday through Friday between 7:45am and 4:30pm.

MINDS ON THE EDGE: Facing Mental Illness zeros in on wrenching situations playing out every day in hospital ERs, on city streets and school campuses, in courtrooms and in jails, as Americans struggle with serious mental illnesses like schizophrenia and bipolar disorder. The dramatic scenario of this Fred Friendly Seminars program reveals personal dilemmas facing individuals and families, medical practices that can be obstacles to treatment, and public polices that are falling short.

Moderated by Frank Sesno, the program features Supreme Court Justice Stephen Breyer, Nobel-Prizewinning neuroscientist Eric Kandel, Pulitzer-nominated journalist Pete Earley, and other panelists from law, medicine, and public policy — including several who have personally faced the challenges of mental illness and offer their riveting insights. SENIOR FAIR SURVEY RESULTS- 89 respondents

- 1. What should our Governor and legislators do to meet economic crisis? Top suggestions: Taxes were biggest items:
 - 1) Tied for No.1: **Increase** taxes on G.E.T. to 5%, raise tax on top 10% of wealthy, increase hotel tax, tax rate on liquor, cigarettes, entertainment, out-of state and country speculators, better collection and enforcement. **Decrease** taxes on real property for seniors, stop raising taxes, eliminate rail tax on GET.
 - 2) Next highest: Cut back on bureaucratic personnel, use more volunteers, take a pay cut.
- 2. Has economic crises affected you personally? Yes <u>62</u> No <u>27</u> In what way?
 - 1) Higher taxes,
 - 2) Higher prices,
 - 3) Laid off or worry about state job, lower pay
- 3. What issues are of greatest concern to senior citizens?

By far and away the greatest concern:

- 1) Paying for health care, prescription drugs and long term care.
- 2) Next was the high cost of living, rising costs food, gas, rents, housing, taxes.
- 3) Third was transportation.
