## Notes from August Luncheon: Jacob Silva: St. Francis "Staying Healthy At Home"

Staying Healthy at Home is a health and wellness program designed for healthy seniors as well as for seniors and individuals living with a chronic condition who enjoy their independence but may require assistance with daily activities. As an alternative to assisted living facilities and nursing homes, it acts as a one-call center for all the services you may need.

The annual membership fee of \$600 per person, \$900 per couple includes home safety evaluation, health screenings, weekly follow-ups, chronic disease management, pharmacist medication reviews, initial consultation for estate planning, invitations to educational seminars, volunteers to assist with errands and light housekeeping.

Other services such as yard service, transportation, adult day services, personal medical alert systems, bathing & personal services are available on a fee-for-service basis.

If a member is no longer able to stay at home, a social worker will help find an appropriate placement.

## AARP reports nearly 11 percent of Hawaii residents aged 50-64 are without health insurance. As the economy worsens, this number is likely to increase.

## **MESSAGE FROM Neil Abercrombie, Member of Congress**

So far, Hawaii is receiving more than \$1.3 billion. These projects include:

#### Education

- \$192 million: State Fiscal Stabilization Fund, a one-time investment to stabilize state and local budgets and help them avoid cuts in education and other essential public services.
- \$33 million: Elementary and Secondary Education Act grants, to schools with low-income children to help every child to meet state academic standards.

### Law Enforcement

- The Honolulu Police Department: \$5.2 mil for salary and benefits to add 21 additional police officers.
- The Hawaii Attorney General: \$6.4 million for efforts against sex crimes, gang violence, property crimes, cyber crimes, and for drug and mental health courts, youth services and drug enforcement.

#### Defense

- \$31 million for facilities maintenance, restoration and modernization of the Kauai Pacific Missile Range.
- \$20 million for the repair of Wharf S1 at Pearl Harbor Naval Station.

#### Health and Human Services

- \$136 million to avoid cuts in Medicaid.
- \$8.5 million to upgrade and expand Hawaii's Community Health Centers.

#### **Transportation**

- \$43.8 million in federal funding for Hawaii's mass transit system.
- \$18 million for bridge replacement and improvement at the Punaluu Stream on Kam Hwy.

• \$15 million for repairs and improvement at Maui's Kahului Airport.

## PROJECT DANA HAS RECEIVED A GRANT FROM HAWAII COMMUNITY FOUNDATION'S "PIN" (PERSONS IN NEED).

It provides assistance to those in need of transportation to medical visits or shopping; respite to family caregivers; or installation of home safety devices to prevent falls in their homes. Those 65 years and older on Oahu are encouraged to apply; preference to those with financial need. For those needing respite, this one time funding may help pay for Adult Day/Health Care or a private hire from an agency. Funds are also possible for those who serve as drivers and provide transportation. Some funds may be approved for taxi fares to those needing transportation to medical appointments.
