# Notes on presentation by Judy Mohr Peterson, Medicaid Director for Hawaii (January 26, 2016)

Dr. Mohr Peterson has been going around the state listening and learning. Her emphasis is not on administration or delivery systems but rather on outcomes. Research says our Zip code is more predictive and influential than our genetic code. The community, the family, the diet, the physical environment, pollution, all influence outcomes.

80 percent of health outcomes are related to factors outside the medical system. Hawaii is seeking to create a more efficient and effective health care system to address disparities among groups.

Mohr Peterson emphasized that DOE, DHS, DOE, Insurance companies, hospitals, etc. need to work together to address the following:

- Access to health insurance
- Transitions especially out of the state hospital, prisons, etc., providing appropriate support.
- Addressing the whole person citing comprehensive dental care as an example
- Connecting behavioral and physical health delivery systems citing homelessness as an example
- Focus on prevention and early intervention at the primary care doctor stage for both physical and behavioral health issues citing professional development for primary care physicians and telemedicine particularly for Neighbor Isle patients
- Improving choices and quality of life for those institutionalized choice of food, roommates, privacy, visits.

## Q&A

Many questions were raised regarding Medicaid eligibility.

Dr. Mohr Peterson admitted that their administrative and tech capabilities were not yet sufficient to accomplish all their goals, but they are making slow progress.

We should focus on Economic Justice: A fair opportunity for everyone to achieve an adequate economic life, food, housing...especially for the low and moderate income people. Some structural issues for Hawaii include:

• We typically pay more than 50 percent of our income for shelter

- Hawaii has the lowest wages in the US
- Hawaii has the second highest tax rate imposed on low and moderate incomes
- 48 percent of Hawaii government is supported by the regressive GET excise tax

Affordable Housing (See Appleseed Report: <a href="http://www.hiappleseed.org/affordable-housing-crisis">http://www.hiappleseed.org/affordable-housing-crisis</a>)

Geminiani emphasized three promising areas of relief for affordable housing: Transit Oriented Development, Accessory Dwelling Units (allows seniors to age in place and uses existing private residential lands), and Micro-units (250-350 square feet) – which we used to call Single Room Occupancy.

We have the highest rate of homelessness among the states, with no decrease in sight. More than 13,000 individuals throughout the islands received homeless services in 2013—42 percent of whom were new clients. Thousands more households are at risk of homelessness or are part of "the hidden homeless," forced to double up with other families out of economic necessity.

Key recommendations in the report include:

- Increase government support and planning for affordable housing
- Adopt innovative models such as micro-apartments and accessory dwelling units
- Take advantage of Transit Oriented Development and urban infill to maximize affordable housing creation; and
- Expand use of the Housing First approach to quickly help stabilize people experiencing chronic homelessness
