The Complications of Condos

- A Condo has its own limited, less transparent democratic rules, limited oversight over its governance, and a "taxation" scheme (maintenance fees) not based on income or unit value (unlike that for single family dwellings).
- The Board of Directors and a small group of owners tend to control the decisions that have a financial impact on residents. Major cost items may result in residents of limited income or finances losing ownership of their units.
- Falls under completely *separate regulatory and consumer protection section of the law* that is less robust than for other segments of the community.
- Completely separate advocacy groups, representing condos as businesses or representing condos as communities.
- The likelihood that the most vulnerable seniors are older women, who have had less lifetime income, and thus less retirement payments (if any at all) and less social security payments.
- General increased privacy of residents, which means it is possible that a resident is not known by neighbors, which means their needs may not be known. Issues relating to sanitation, hoarding, forgetfulness with water and appliances, and dementia or other frailties may make it difficult to respond to challenges that impact other residents.
- Increased vulnerability in the loss of electricity in the building, during fire, or a longer-term issue, i.e. natural disasters such as a hurricane hitting Oahu. While many condos have generators, not all are capable of running an elevator.
- Hit and miss interest and capacity of resident managers to keep track of or monitor the more vulnerable, manage the population or the property.
- Indirect outsourced management companies which may or may not have trained and licensed agents which has implications for costs and safety improvements.
