

# **KOKUA COUNCIL LEGISLATIVE PRIORITIES - 2009**

ADVOCATE: Kokua council takes the lead in advocacy. The Council will testify and work to generate numbers of supporters to appear and/or testify on behalf of the matter. (No more than four issues.)

#### LONG TERM CARE/HOME FOR LIFE

#### SENIOR ADVOCATES WORKING TOGETHER

Kokua Council and other Senior advocacy groups are working together as a way to strengthen our effectiveness with public policy makers. The Senior Advocacy groups are Hawaii Alliance of Retired Americans (HARA); Policy Advisory Board for Elderly Affairs (PABEA); Faith in Action for Community Equity (FACE), Hawaii Caregiver Coalition (HCC), Hawaii Aging Advocates Coalition (HAAC), Na Tutu, Grandparents Coalition and PHOCUSED. Our 2009 Priorities are written in general terms so that we can be flexible as the bills are introduced for hearings later. However, as of this printing, we know that the Legislative Kupuna Caucus will be introducing certain bills covered under our designation of Long Term Care/Home for life. Listed below are our priorities described in greater detail.

#### UNDER LONG TERM CARE/HOME FOR LIFE

#### **ADVOCATE**

**Public posting of annual care home and foster home assessments.** We are supporting a recommendation by the **Ombudsman's office** that the public have access to the same kind of information as is available for nursing homes. Residents and potential residents and their caregivers should have information relevant to quality of care in making their decisions.

**Policies to assist in balancing employment and caregiving.** In the 2008 Session, the Legislature considered the model of **paid family caregiver leave** in California and a recent one enacted in New Jersey, which provide for paid leave through the Temporary Disability Insurance program based on employee contributions. A taskforce has been working to examine the feasibility of a similar policy and to work out details for a proposal for Hawaii. A bill is needed to extend the taskforce and provide some resources for more data collection.

**Financial support for family caregivers**. A contract was executed to design a **cash and counseling** program for non-Medicaid caregivers. Funds could be allocated either to directly to caregivers or a 3<sup>rd</sup> party to be used for services the caregiver would choose with help from a case manager. A demonstration project is being proposed and external grant money being pursued to implement the project.

**One-Stop Center.** The Hilo Center will open in February, Oahu's virtual site is still being developed. Both Hilo and Oahu need state funds to continue.

#### **SUPPORT**

**Grandparents raising their grandchildren**. The 2008 Legislative Session established a taskforce to examine the issues and develop proposals for legislation. Bills are being proposed to address a number of legal issues, such as legal guardianship, and other problems in education, health care, respite, housing and financial resources

**UH Center on Aging Research and Education (CARE)**. The UH Center on Aging has ceased to offer its degree programs due to the lack of financial resources to hire faculty. While a \$2 million grant was gifted to the university only \$100,000 is available each year. More funds are needed for the recruitment of a director for UH CARE and the development of the curriculum. We expect a bill will be introduced to add funds to the University budget for this purpose.
